NOTICE :

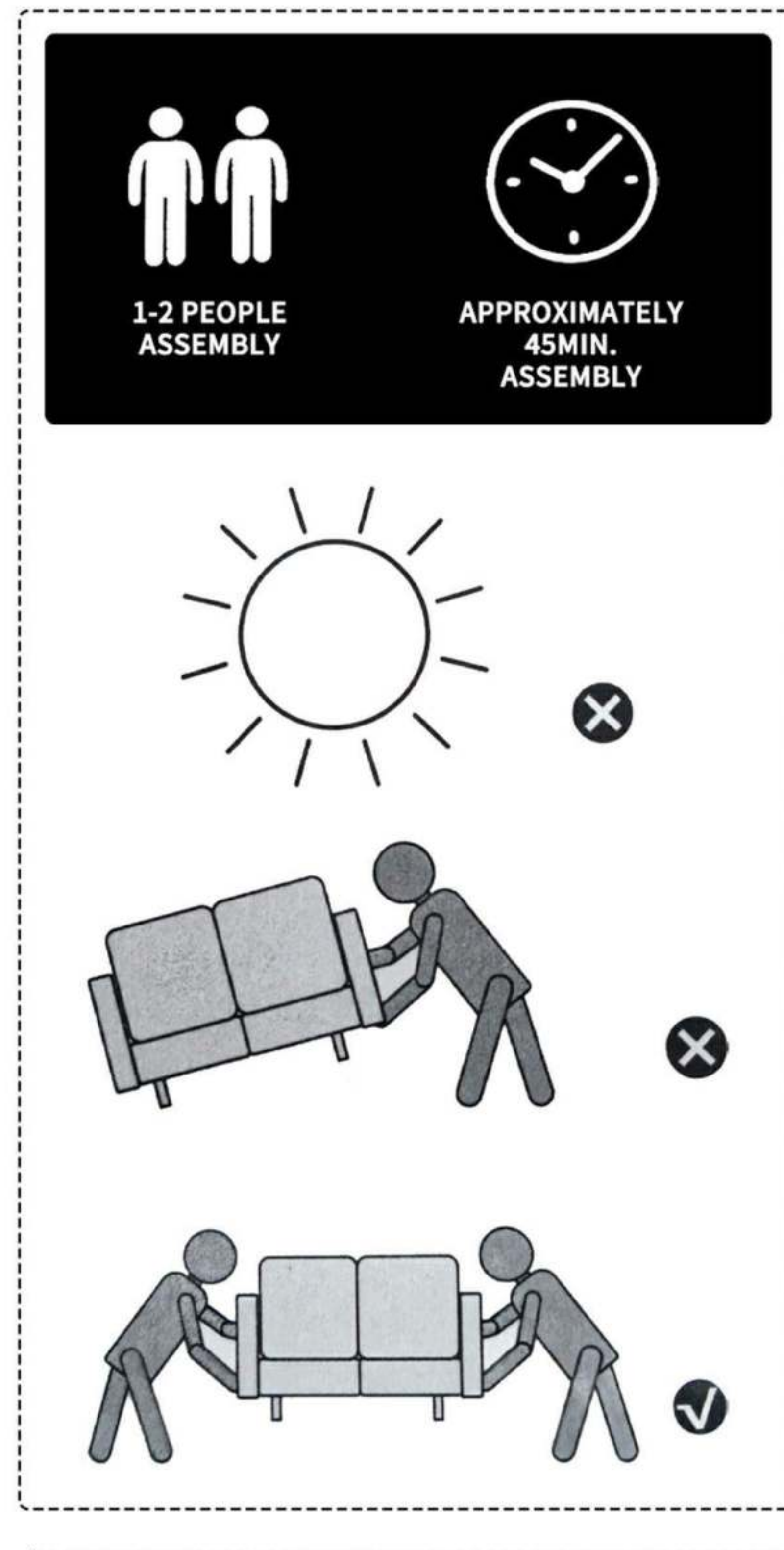
Please retain these instructions for future reference.

- Please read the instruction sheets completely before assembly. Remove all parts from carton and, ensure all parts are included prior to assembly.
- Assemble the sofa on a protected surface to avoid scratching the components of sofa. Be careful not to cross-thread screws.
- Do not use power tools
- Two people are recommended for assembly
- If the sofa is smelling, please try to air it for 24-48 hours and the smell will go away. Sometimes it's because it was packed for a long time, so it's very normal to get that smell.
- Our Sofa is certified by the environment system. So please don't worry, it won't hurt your health, it's safe to use it.

RETURN/DAMAGE CLAIM INSTRUCTIONS:

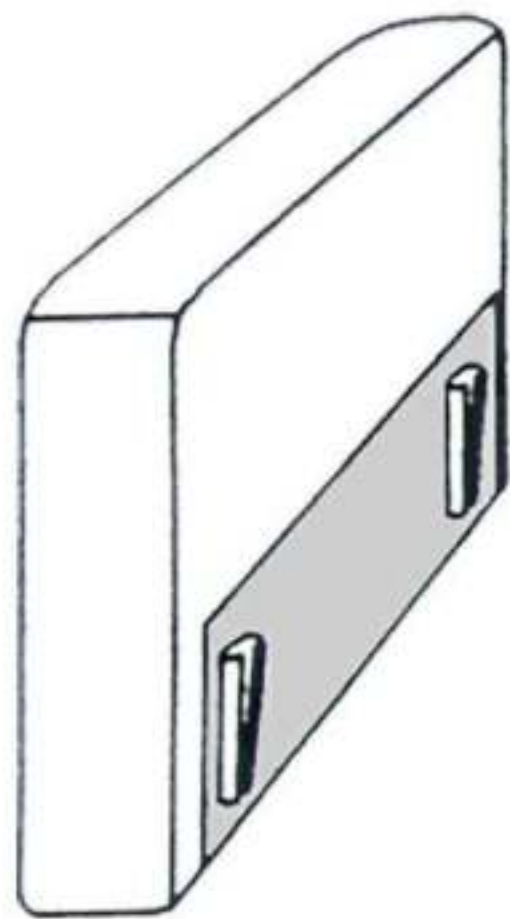
- DO NOT discard of the box/original packaging. In case a return is required, the item must be returned in original box. Without this your return will not be accepted.
- Take a photo of the box markings. A photo of the markings (text) on the side of the box or instruction is required in case a part is needed for replacement. This helps our staff identify your product number to ensure you receive the correct parts.
- Take a photo of Damage (if applicable). A photo of the damage is always required to file a claim and get your replacement or refund processed quickly. Please make sure you have the box even if it is damaged.
- Send us an email with the images requested. Email us directly from marketplace where your item was purchased with the attached images and a description of your claim.

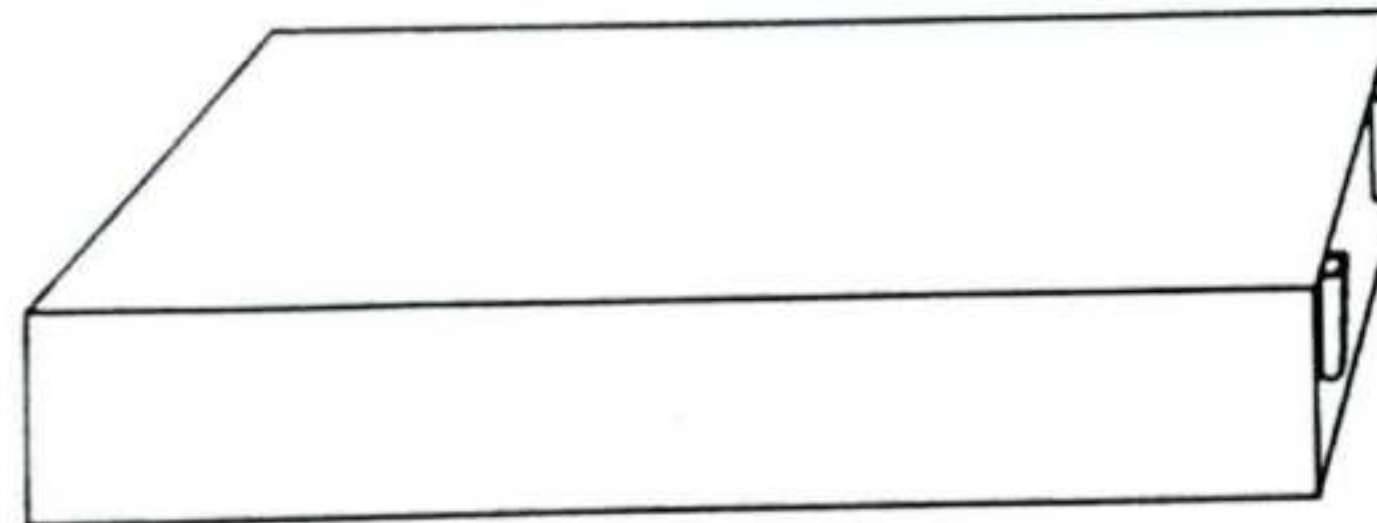

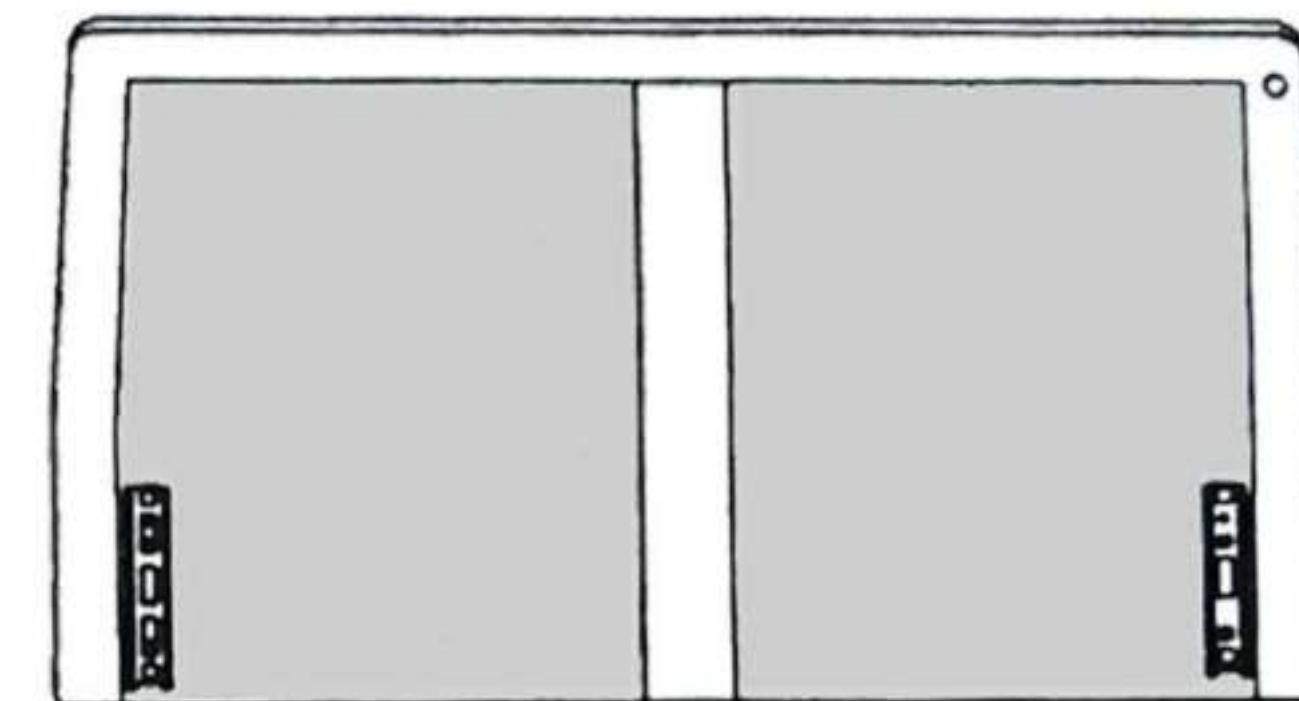
Carton A : Rectangular carton (HB-D)(46.07*24.41*13.39inch)



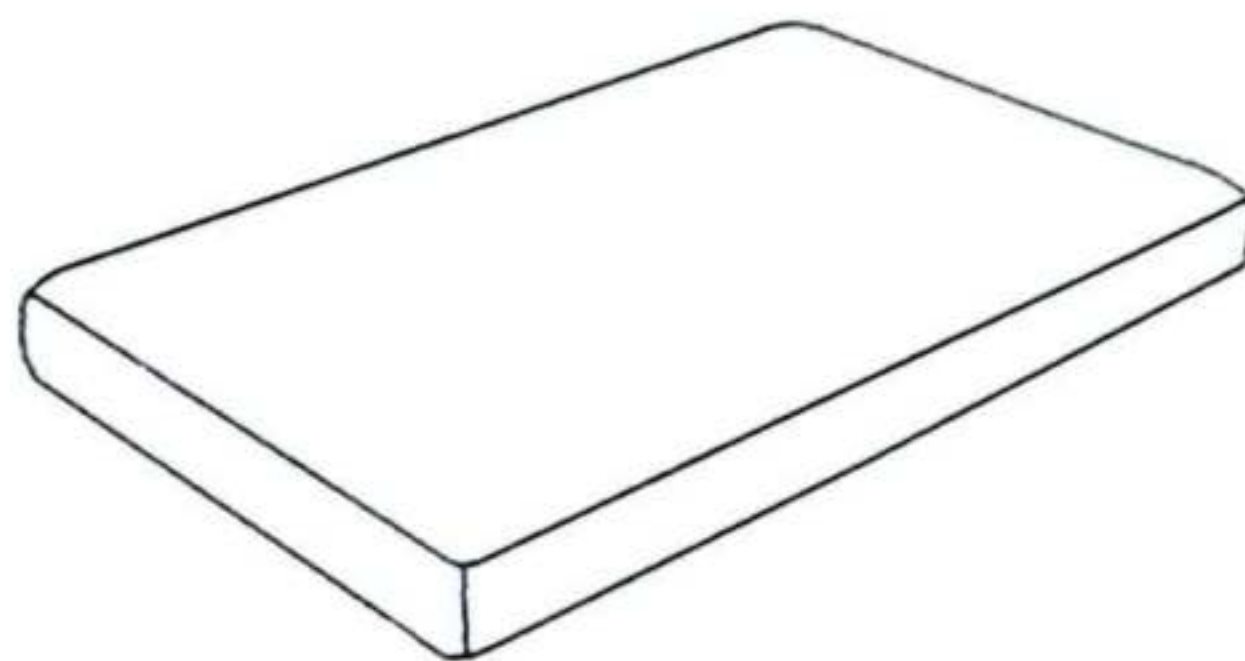
A Right armrest (1)

C Double backrest (1)

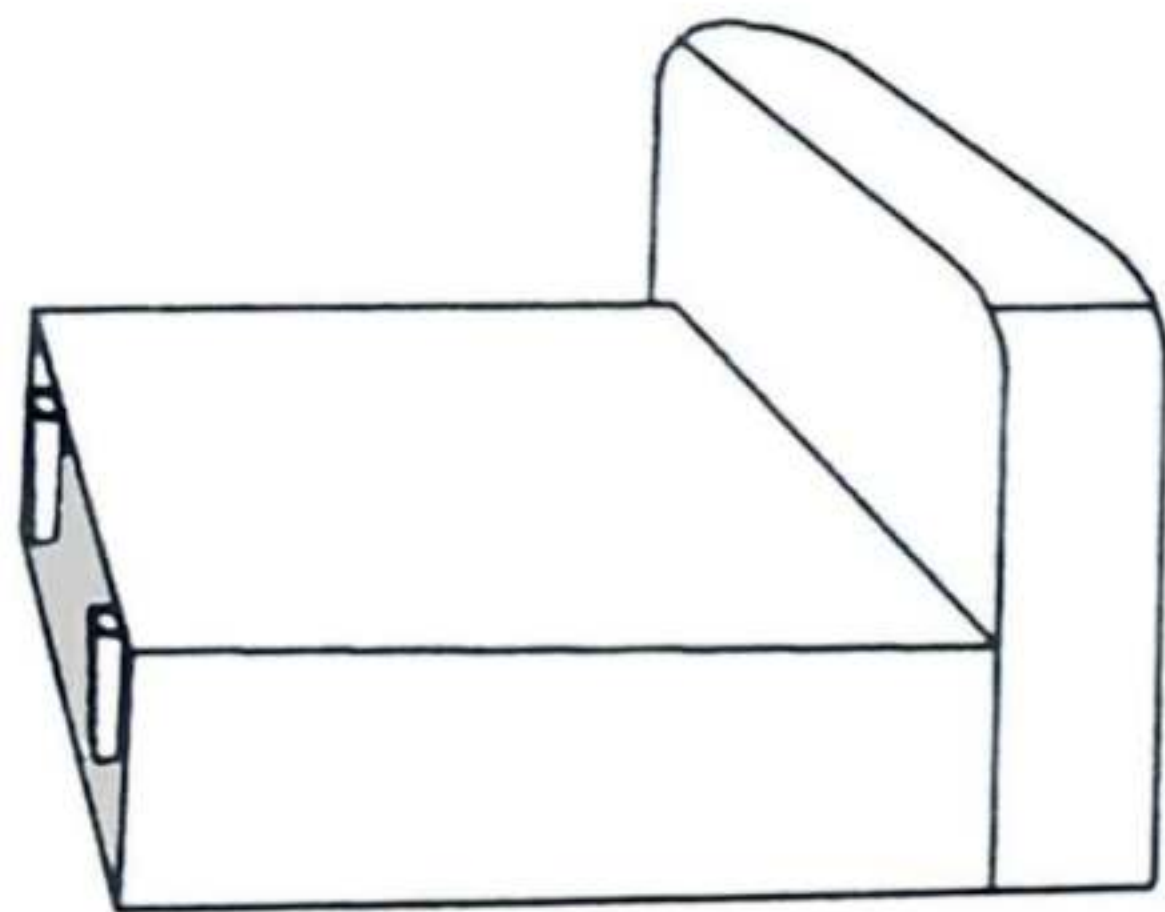

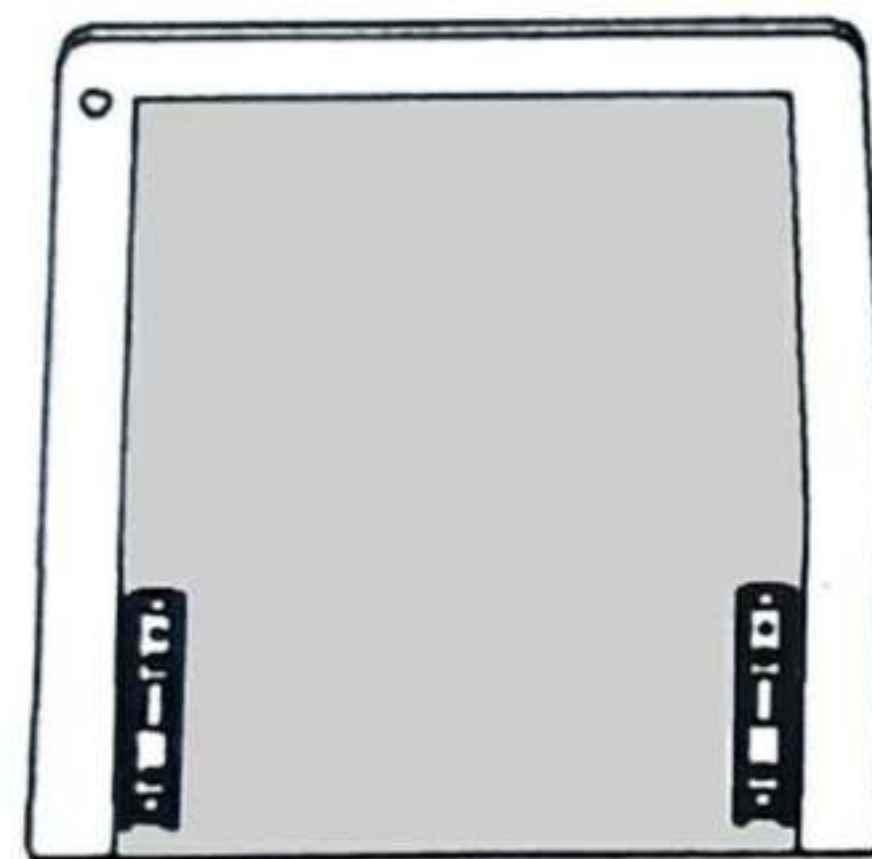

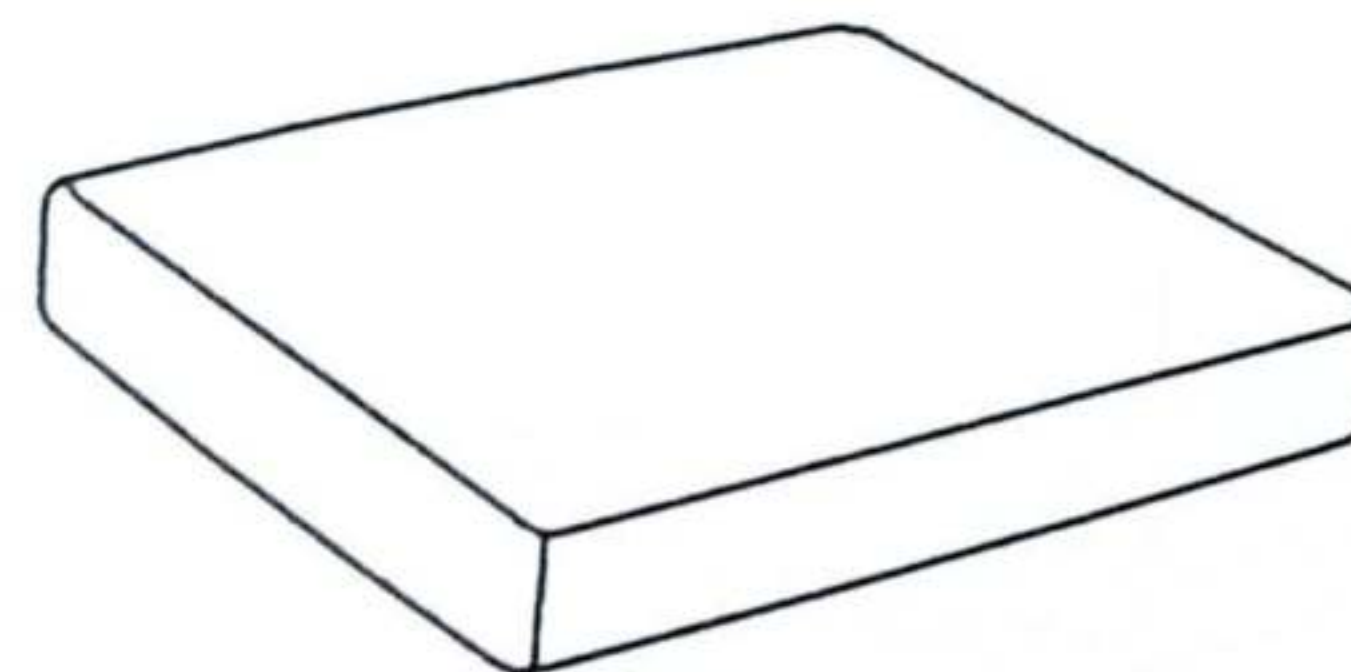


E Left armrest(1)

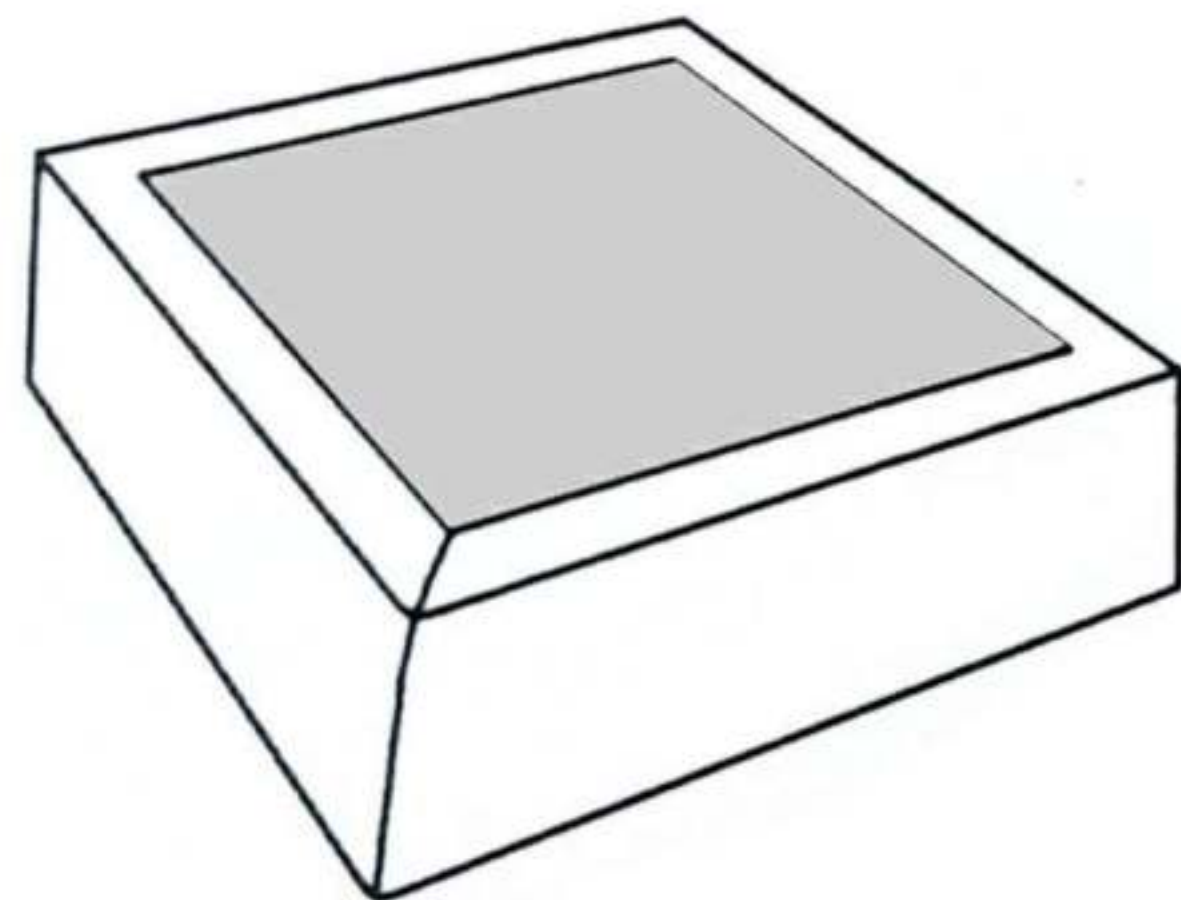

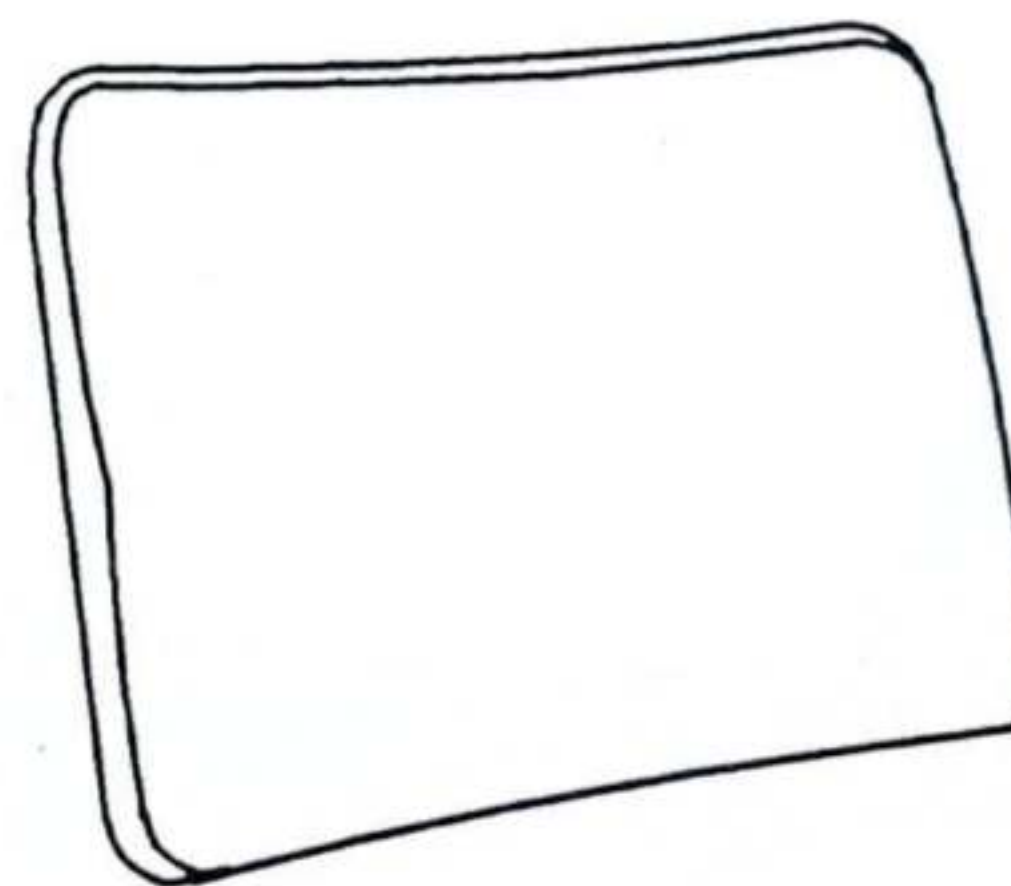

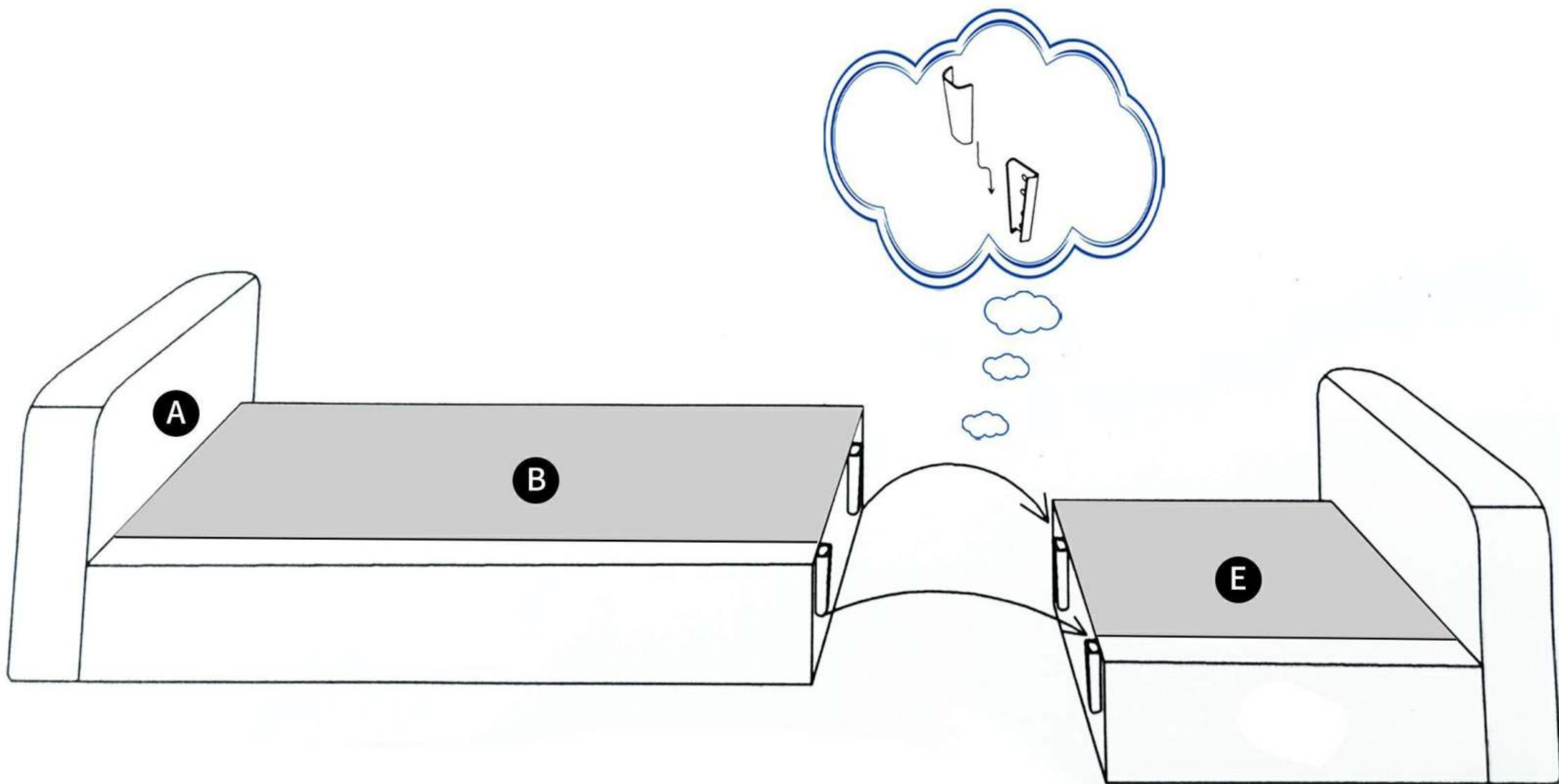
Remove all parts from the carton A carton B and place them on a protected surface or carpet.

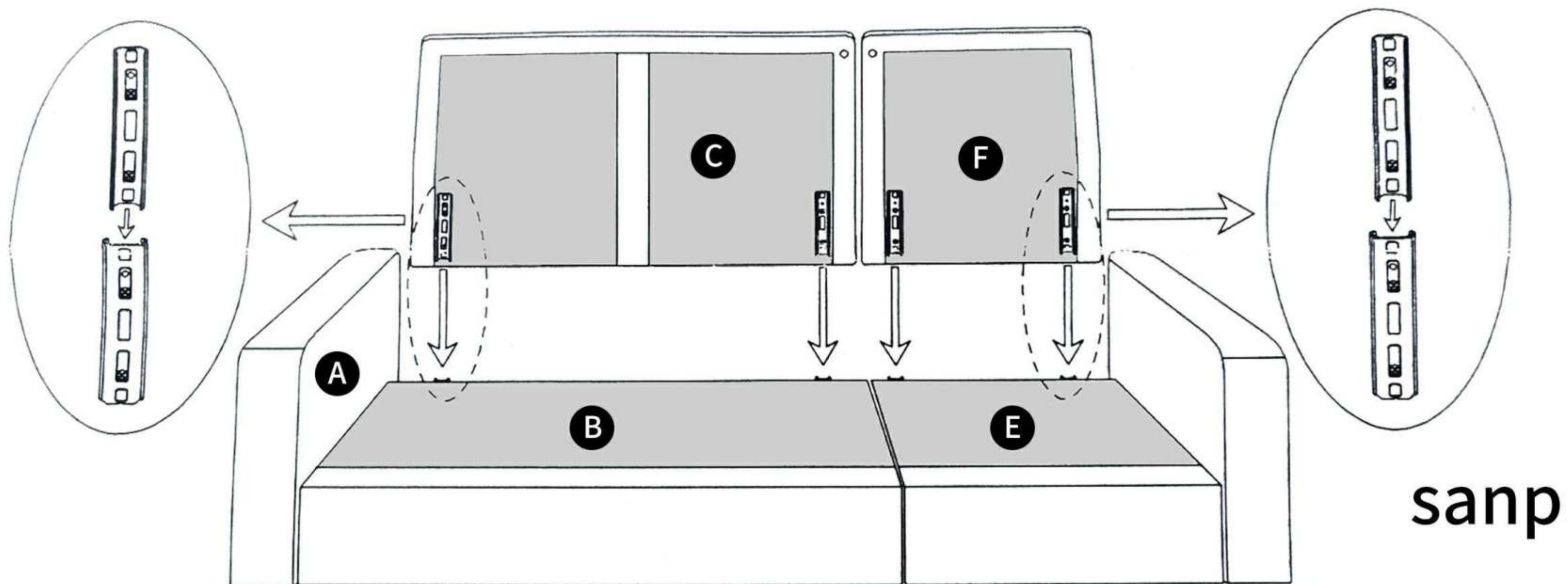
Insert the right seat into the right armrest.

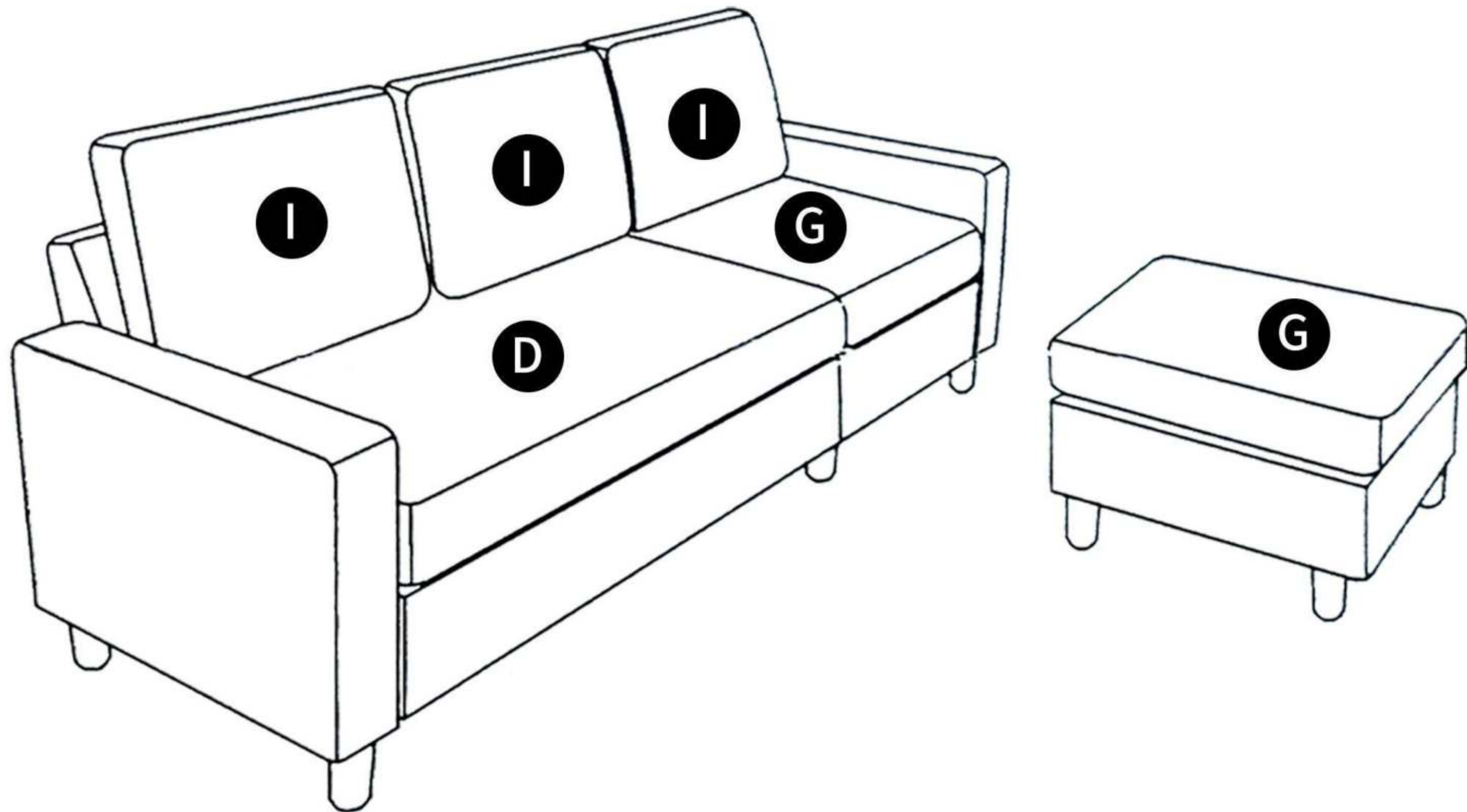


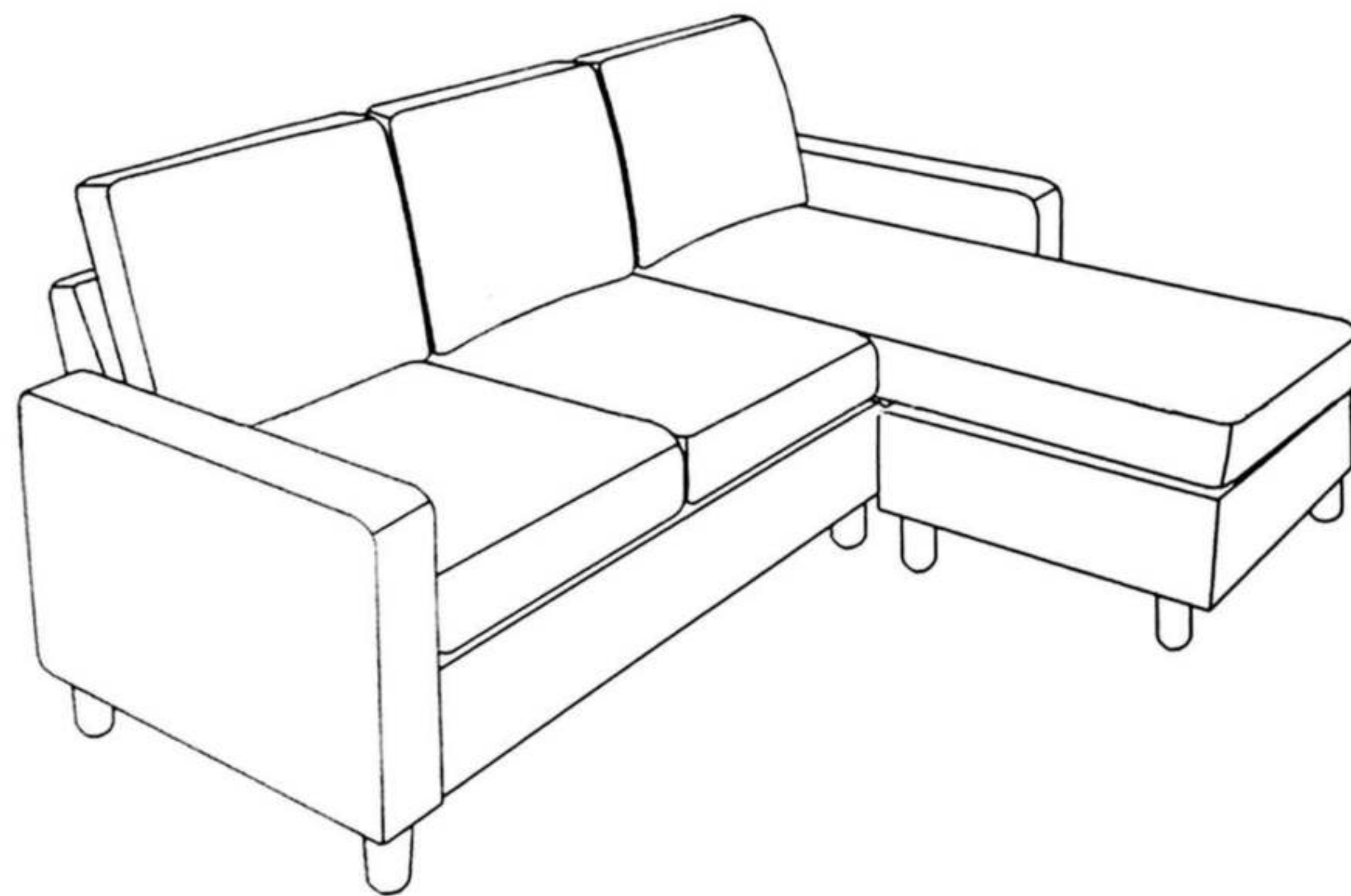
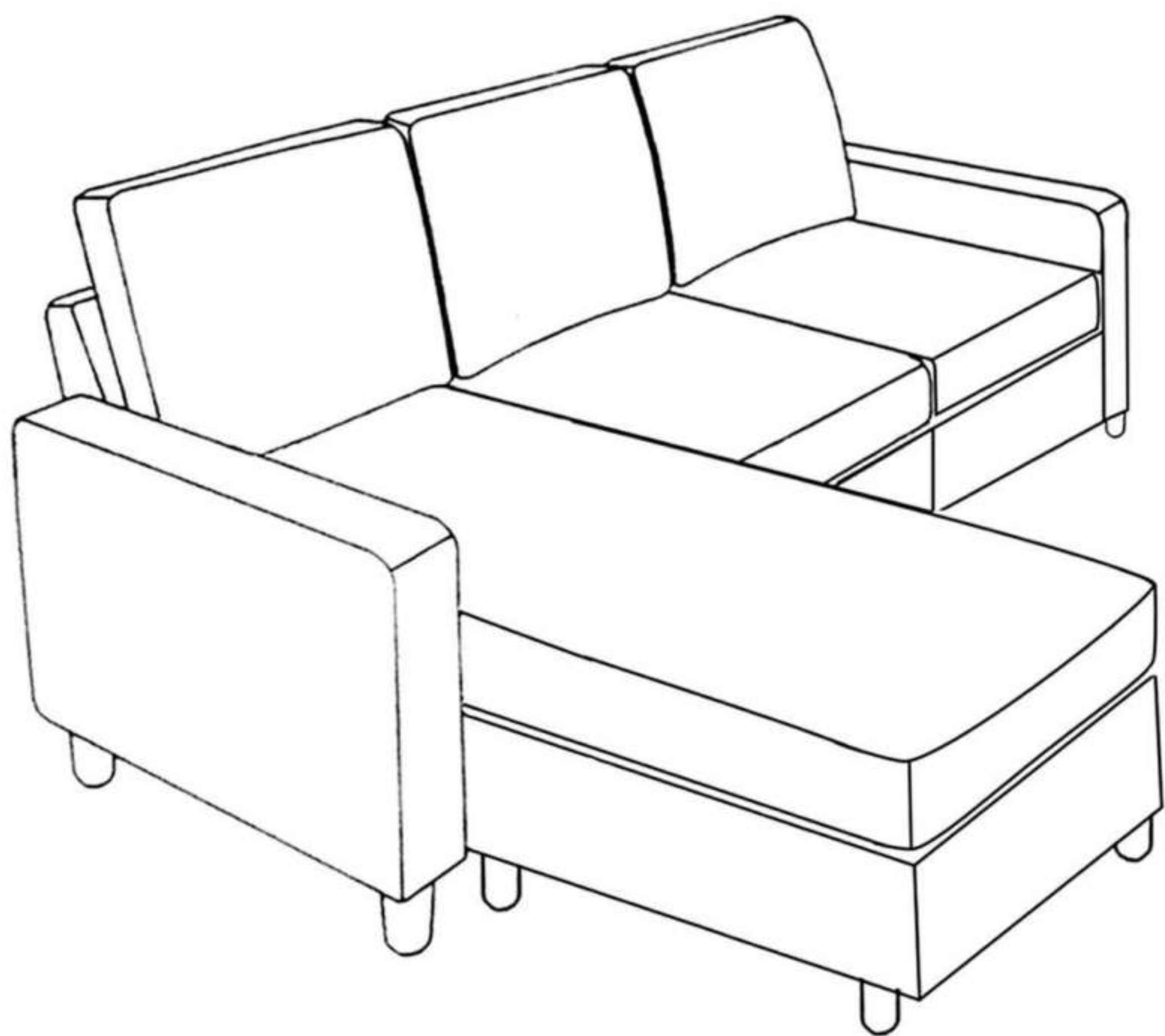
Step 7 : Compressed back cushion and seat cushion should be recovered 72 hours after opening.

LIMITED WARRANTY

The sofa seating, products are warranted against defects in material and workmanship while owned by the "Original Purchaser". The term "Original Purchaser" is defined as that party or entity which purchases The sofa furniture from an authorized The sofa retailer as shown by the original sales receipt. This warranty does not apply to "as is" or previously owned seating products. The sofa warrants its products to be free from defects in materials and workmanship (normal wear and tear, fading and stretching excepted), for one year from the date of purchase, except as provided below under the limited warranty.

The exceptions or exclusions to this warranty are as follows:

1. Any warranty claim that is submitted after the limited warranty period, or without proper proof of purchase will not include the cost of parts, labor, or delivery.
2. This warranty shall not apply to the The sofa products which have been subjected to misuse, neglect, alteration, modification, or attachments, either caused by the original purchaser, shipping, storage, accident, fire, or acts of God.

In the event of a defect in material or workmanship covered by this warranty, The sofa will repair or replace, at their discretion, without charge the warranted furniture within a reasonable amount of time. We reserve the right to require damaged parts to be returned to us upon request. The sofa markings such as cars, brands, grain variations, wrinkles, color variations, etc. will be considered normal characteristics and not construed as defects. We cannot warrant leather against scratching or scuffing, as all leather is subject to blemishes with use.
